This programme aims to raise awareness in Ireland and elsewhere of the scale, dimensions and causes of world poverty and to advocate for policies to overcome it.

Trócaire, in producing the *Trócaire Development Review*, draws together policy analysis and research findings with particular relevance to Ireland's evolving role in international development. *Review* articles are on economic, social and political themes related to poverty and injustice in the developing world. In general, individual country case studies should only be used to illustrate a general argument. Research findings on pertinent issues would be particularly welcome. All articles are subject to blind peer-review by the Editorial Committee; articles should not exceed 7,000 words. Short notes and comments are also welcome.
